

# BOARD OF TRUSTEES, CONSTITUTION ETC:

  - k) A resolution in writing circulated amongst all the members of the Board and passed by a majority of the Trustees shall be valid and effective as if it had been passed at a meeting of the Board of Trustees duly called and convened in that behalf.
  - Minutes of the present and every meeting of the Board of Trustees shall be entered in a book to be kept for that purpose only and signed by the Chairman of such meeting or of the following meeting after they have been read and so entered and signed as a conclusive evidence of the business and other matters transacted.
