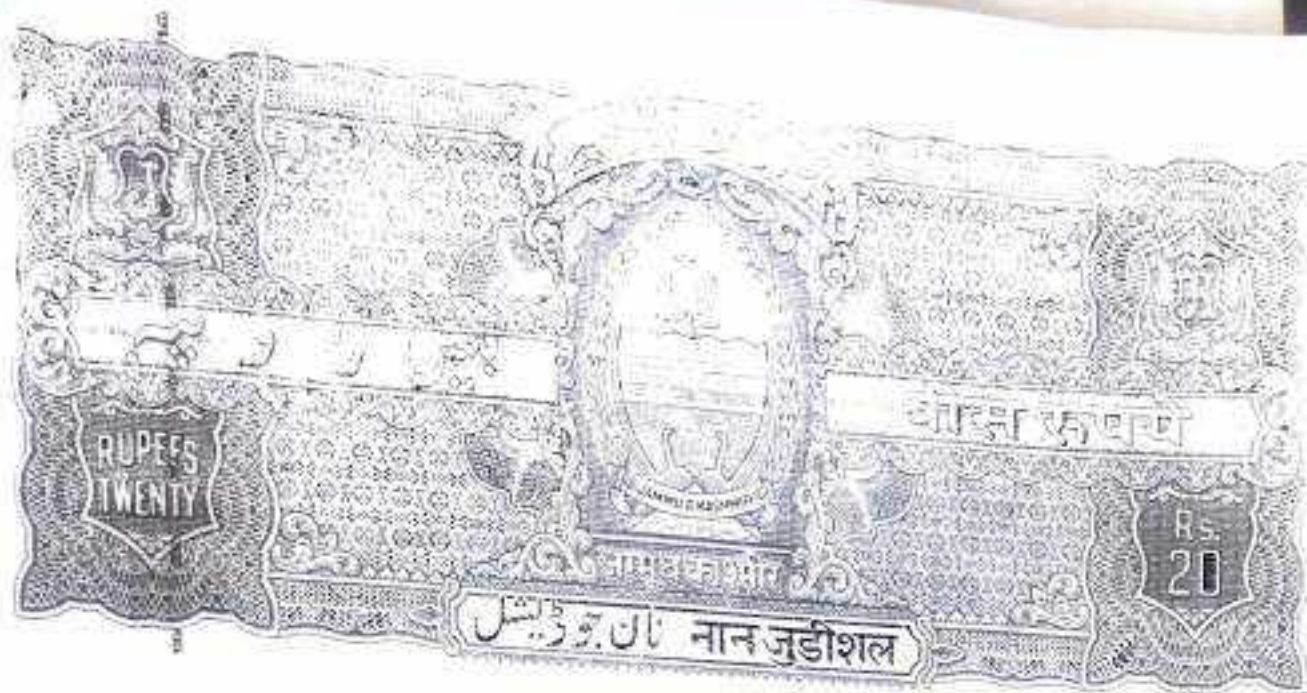

- m) To promote youths in the field of education , sports ,science and technology with special concentration on youth of border areas and rural areas .
- n) To promote activities in the development and preservation of environment and forestation .

**6 BOARD OF TRUSTEES, CONSTITUTION ETC:**

- a) The administration, management and control of the Trust and its properties shall vest in the hands of the Board of Trustees, consisting of above mentioned persons for the time being. The Board shall have powers to nominate additional Trustees for a period of two years, as also any vacancy caused by any reason , but the total number of Trustees shall not exceed nine . The additional trustee retiring after two years may be reappointed by the Board of Trustees .
- b) The founder trustees shall hold office during their life unless any of them desires to be discharged of his duties or becomes mentally or physically incapable of working .
- c) The trustees shall be entitled to reimbursement of expenses incurred by them in the conduct of their duties or in promotion of the objects of the trust or on behalf of the trust .
- d) The trustees may institute, conduct, defend, compound or abandon any legal procedure by or against the Trust or Trustees and allow time and indulgence for payment or satisfaction of any debt due or for any claims or demands by or against the Trust .
- e) Er Nimraudeep Singh shall be the first Chairman of the Trust . The Chairman is authorized to appoint working chairman in his place if he feels it is necessary for smooth running of Trust .
- f) The Trustees shall have the power to accept honorary services of any person volunteering to do the work in the Trust or in the Charitable institution, run by the Trust . The Trustees shall have full discretionary control and power over such staff employees, workers, officers .

- g) The Trustees shall appoint the president, secretary and treasurer for the smooth running of the Trust and the period of committee will be decided by the trustees in the Board of Trustees meeting. Thereafter new committee will be formed.
- h) The Chairman may at his discretion convene a meeting of the Board of Trustees.
- i) The Chairman can remove any trustee from the board who works against the objectives of the trust or who fails to deliver as per the requirement of the board.
- j) All questions arising at a meeting of the Board of Trustees shall be decided by a majority of votes, and in the case of equality of votes, the chairman shall have a casting vote.
- k) A resolution in writing circulated amongst all the members of the Board and passed by a majority of the Trustees shall be valid and effective as if it had been passed at a meeting of the Board of Trustees duly called and convened in that behalf.
- l) Minutes of the present and every meeting of the Board of Trustees shall be entered in a book to be kept for that purpose only and signed by the Chairman of such meeting or of the following meeting after they have been read and so entered and signed as a conclusive evidence of the business and other matters transacted.
- m) The Trustee shall be entitled to be compensated for any liability incurred by them on account of their acts and deeds in good faith and good intention, done for the Trust.
- n) Any Trustees may retire by tendering resignation and giving charge of the Trust property under his control and it shall not be necessary to give any reason for the same.

- h) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust Fund.
- i) To appoint constituted attorney or agents and to delegate to such attorney or agents all or any of the powers vested on them under these presents and from time to time remove such attorneys or agents and to appoint other or others in his or their place.
- j) Trustees to hold any fund or investment subject to the provisions of this Deed in such manner and subject to such rules and regulations as the trustees may from time to time think.

All the documents/papers of the Trust shall remain in the custody of the Chairman and he shall be personally responsible to preserve them.

#### ADVISORY BOARD

- a) The Trustees may appoint or nominate some persons as the Advisors/Consultants in the Trust just for obtaining their advice, view, etc for the smooth running of the Trust. They may be compensated with suitable honorarium.

That in continuance of the above mentioned matters, the Settlor and the Trustees can further add, amend, alter, change any terms and conditions or any matter which may be deemed to be important and necessary in the interest of the Trust from time to time.
